Title I Parents Right-to-Know

Parents Right to Know - Teacher Qualifications:

You have the right to know about the teaching qualifications of your child's classroom teacher. Federal law requires that any local school district receiving federal Title I funds, Improving the Academic Achievement of the Disadvantaged, must notify parents of each student attending any school receiving Title I funds that they may request information regarding the professional qualifications of the student's classroom teacher, including the following:

- I. Whether the teacher has met State qualification and licensing criteria for the grade levels and subject areas in which the teacher provides instruction;
- II. Whether the teacher is teaching under emergency or other provisional status through which State qualification or licensing criteria have been waived; and
- III. Whether the teacher is teaching in the field of discipline of the certification of the teacher;
- IV. Whether your child is provided services by paraprofessionals and, if so, their qualifications.

You will be notified if your student has been taught for four or more consecutive weeks by a teacher who does not meet the applicable state certification requirements at the grade level and subject area in which the teacher has been assigned.

Parents Right to Know – Student Participation in State Mandated Assessments:

You may request policies regarding student participation in state mandated assessments as well as disseminating through public means information on each assessment required by the state.

Parents Right to Know – Limited English Proficient:

Evidence of notifications regarding service and parental participation, in a timely manner (30 days after the beginning of the school year, or within two weeks of the child being placed in the language instruction program) and in an understandable and uniform format, to parents of an identified Limited English Proficient student eligible for Title I and/or Title III participation. [ESSA 1112(e)(3)(A)(B)(C)(D)(4)]
