6.24 REMOVAL FROM EXTRACURRICULAR ACTIVITIES

Participation in extracurricular activities is a privilege held by Franklin Local students, and not a right. This privilege can be taken away if a student violates the Athletic Code of Conduct or the Student Code of Conduct. Athletes are school role models and, therefore, should conduct themselves as such. This policy shall be posted in a central location in each school building and will be made available to students upon request.

The Superintendent, principal, or assistant principal may deny a student the privilege of participating in any particular or all extracurricular activities for a stated period of time, but not to exceed one (1) full school year.

Students who are suspended or expelled from school shall not participate in or attend any extracurricular activities for the duration of the suspension or expulsion.

A student who is absent the day of an extracurricular event shall not participate in the scheduled activity.

Procedure

Any student who is the subject of a removal from extracurricular activities has the right to notice of that removal and the opportunity to be heard with regard to the removal.

Before being removed, the Superintendent, principal, or assistant principal considering the removal shall provide the student with the following:

A. Written notice of the intended removal, the length of the intended removal, and the reasons for the intended removal; and

B. An opportunity to appear at an informal hearing before the Superintendent, principal, or assistant principal to challenge the reason for the removal, or to otherwise explain the student's actions.

If a removal is imposed, the student athlete will receive written notice of the removal, including the reasons for the removal, the beginning, and the end date of the removal. The decision of the Superintendent, principal, or assistant principal shall be final, and the student shall not be entitled to further notice, hearing, or appeal rights.
