

Student Conduct Code for Transportation and Bus Route Schedule

Franklin Local Schools will begin classes for the 2024-2025 school year on Wednesday, August 21, 2024. The enclosed transportation schedule is provided to give parents and students information about the approximate geographic area of bus travel, the bus drivers' names, and the bus numbers.

High school, middle school, all joint vocational school and parochial students will be picked up between the hours of 5:50 and 7:15 A.M.

Responsibilities

Board of Education

- 1. The Board of Education is the policy-making agent of the transportation system, as well as of all other phases of school operation. It is responsible by law for the general operation of school transportation. The Board delegates the administration but not the legal responsibility to the Transportation Supervisor through the Superintendent. The Board is the agency of appeal concerning administrative decisions.
- 2. The Board of Education, through the Transportation Supervisor, Assistant Superintendent, and the Superintendent, plans bus routes and designates bus stops. The number of stops shall be limited as much as possible. Where children from several homes can safely meet at a central point, this point shall be the only stop scheduled in this area.
- 3. Due to considerations of safety, liability, and time, buses are not routed on private lanes or roads.
- 4. Children may be required to walk to a bus stop.

Transportation Supervisor

- 1. The Transportation Supervisor shall establish routes and maintain passenger lists with time schedules for each bus.
- 2. The Supervisor shall see that required reports on transportation from himself and the drivers are correctly completed and turned in on time.
- 3. The Supervisor shall see that safe and satisfactory equipment is ready for use each school day.
- 4. The Supervisor shall see that bus drivers are current in State regulated requirements.
- 5. The Supervisor shall gather information on road conditions daily and make recommendations to the Superintendent concerning closing schools.

Bus Drivers

- 1. It is the responsibility of each school bus driver to complete and document a daily pre-trip inspection of the school bus before transporting students. They should also post-trip after each route.
- 2. Safety should be foremost in the mind of the driver of any school bus. Bus drivers are to be on the bus when loading or unloading, adjust speed for road and weather conditions, and obey all traffic laws.
- 3. Drivers are to drive assigned buses, follow their assigned schedule and not make a practice of arriving at school buildings to unload or load pupils before the designated time for that building.
- 4. Necessary repairs to be made on a bus are to be written on a work order and turned in to the Transportation Supervisor.
- 5. In case of a breakdown enroute, the garage should be contacted for service.
- 6. Drivers are responsible for student conduct on the bus; all state & district laws, regulations and policies are to be enforced. Discipline cases are to be reported to principal.
- 7. Students are to be picked up and discharged only at authorized stops.
- 8. Only authorized students are to be transported.
- 9. All accidents and damage to the bus, such as seats, windows, etc., should be reported to the Transportation Supervisor immediately.
- 10. Bus drivers, while on duty, must not be under the influence of alcohol or drugs or have any odor or effect of alcohol or drugs about them. Use of all tobacco products is prohibited at all times on all school property.
- 11. Drivers are to have a passenger list with Route Sheets available two weeks after school starts. Seats may be assigned by drivers.
- 12. Drivers must have emergency drills at least three times a year, and appoint two students, one in front and one in rear to assist other students in case of an emergency.
- 13. Drivers should look presentable at all times while on duty.
- 14. If a driver is unable to operate his or her bus because of illness or some other reason, the Transportation Supervisor is to be notified as soon as possible.

- 15. To maintain a neat, clean bus that is polished, swept free of dirt, trash and debris.
- 16. Failure to comply with these regulations is grounds for suspension or dismissal.

Responsibilities of School Principals

- 1. The Principal, Transportation Supervisor, and/or bus driver shall cooperate in the solution of disciplinary problems.
- 2. The Principal or designee shall see the orderly loading and unloading of children at the school.
- 3. The Principal or designee shall see that children are dismissed on schedule, and set a maximum waiting time for the buses serving their building.
- 4. The Principal or designee shall keep the bus loading and unloading area free of all unauthorized vehicles.

Responsibilities of Teachers

- 1. Teachers shall teach safety to their pupils.
- 2. They shall perform whatever duties concerning transportation that the Principal may assign.
- 3. Teachers shall dismiss their pupils at the scheduled time, and see that the bus riders go promptly to their buses.
- 4. Field Trips Teachers are responsible to assist the school bus driver in maintaining passenger control and in enforcing safety procedures.
- 5. Teachers shall see that papers carried home by children are sent home in such a manner that the paper will not blow under the bus or into traffic if it is dropped.
- 6. Remember large or bulky items may not be carried on the school bus; take this into consideration when making assignments. (Anything brought on should be able to be held in the student's lap without blocking windows.)

Responsibility of Students

Students have responsibilities that contribute to a safe and orderly bus trip.

- 1. Cooperate with the driver. The driver is in charge of the bus and may assign seats, etc. Please be at your assigned stop 5 minutes prior to scheduled pick-up.
- 2. Ride the regularly assigned bus and unload at the regular stop, unless you have a written permission slip signed by your parent and principal stating otherwise.
- 3. Eating, drinking, smoking, tobacco products, vaping and littering are not permitted on a bus. Help keep the bus clean.
- 4. There must be absolute quiet at all railroad crossings and other places of danger as specified by the driver.
- 5. Noise on the bus shall be kept to a minimum. The same behavior is expected on a school bus as in a classroom, except you may talk quietly to the person beside you, if the driver permits.
- 6. Always remain seated while the bus is in motion.
- 7. Do not throw anything inside the bus or out the window.
- 8. Keep head and hands inside the bus. Windows will not be opened without permission of the driver.
- 9. Cross the street or road at least ten feet ahead of the bus.
- 10. Animals cannot be transported on a school bus, in conformance with state regulations. (Except service animals.)
- 11. Be courteous; use no profane language.
- 12. No dangerous items shall be permitted on the bus, such as glass, sharp objects, firearms, etc.
- 13. Large or bulky items for class projects will not be permitted on the bus due to limited space. These items should be taken to the school by the parent.
- 14. Disorderly conduct or safety violation is sufficient reason for refusing bus transportation.

Responsibilities of Parents

Parents can contribute to the safe and efficient transportation of their children in the following ways:

- 1. See that children are at the proper bus stop five minutes prior to the scheduled time. Drivers are instructed not to run ahead of schedule, and are not required to wait for children, as all children farther along the route would be forced to wait that much longer. On some roads, waiting also causes longer lines of cars behind the bus, creating a traffic hazard.
- 2. See that children ride their assigned buses and leave buses at their correct stops. Any variation of this procedure requires a written permission slip signed by the parent, approved by the school principal and presented to the driver.
- 3. Parents share the responsibility of seeing that children are orderly while awaiting a bus or after unloading on the bus route.
- 4. Parents will be responsible for any damage to a bus by their children.
- 5. Parents should assist the school program by teaching their children good traffic safety procedures and proper conduct.
- 6. Parents are not allowed on the school buses except with authorization from the Transportation Supervisor.

Always be on time for the bus. Waiting for you could make everyone late for school.

Franklin Local School District Procedure to Close Schools in Case of Weather Emergency

The following information is provided to assist you in determining if school has been cancelled:

- 1. Local radio and television stations will broadcast school closing bulletins when emergency weather conditions exist. Every effort will be made to have these bulletins on the air by 5:30 A.M. or as early as possible when a weather emergency has developed. Those with Internet access may also want to monitor www.whiznews.com or the district website at www.franklinlocalschools.org. If no bulletin is announced by the radio stations it should be assumed that Franklin Local Schools will be in session.
- 2. Parents and guardians will also be notified via the Remind system by text, email or phone, of school emergencies, school closings, delays, and early dismissals, as well as announcements of upcoming school and district events.
- 3. All people are urged to listen to the radio broadcast and are asked not to call any school personnel or the radio station. Any unnecessary phone calls tie up telephone lines when they are needed during the weather emergency.
- 4. If the Franklin Local Schools have already opened for the day and a weather emergency occurs during the school hours, it may be necessary to send students home early. Radio stations will be notified if this happens and will broadcast this information.

Student Conduct Code For Transportation Guidelines

School Bus Riding Guidelines

School bus transportation is a privilege and not a right. The bus driver is the sole authority on the bus while students are being transported. It is most important that each student cooperate with the bus driver and practice safe bus riding habits at all times.

- 1. Students are expected to conduct themselves in a proper manner at school bus stops. Behavior must not threaten life, limb, or any individual. The District will not enter into neighborhood disputes involving parents and/or students concerning matters that take place prior to the student boarding the school bus, or after the student has disembarked from the bus on his/her way home. Students must leave unloading areas as soon as possible.
- 2. Students will ride only assigned school buses in seats assigned by the bus driver and will board and depart from the bus at assigned bus stops. Principals may authorize transportation of a school-age visitor to the home of a regular school bus passenger upon proper parental authorization (written request) on a space- available basis which does not displace regular riders.
- 3. A change in a student's regular assigned bus stop may be granted for a special need, if a note from a parent is submitted to the building principal stating the reason for the request and the duration of the change and approval of principal and/or Transportation Supervisor.
- 4. A permanent transfer to another route or bus stop for morning pick-up and/or afternoon drop-off will only be made upon the approval of the Transportation Supervisor.
- 5. Students shall cross all streets at least ten (10) feet in front of the school bus and after the driver has signaled the student that it is all right to do so.
- 6. For the safe operation of the school bus, noise on buses shall be kept at a minimum with students speaking in reasonable conversation voices. Students must be quiet at railroad crossings and other danger zones as designated by the bus driver.
 - a. If you bring your own electronic devices i.e. MP3 players, video games, etc. on the bus, you must use earbuds, headphones, etc.
 - b. Both the use of a bus AM/FM radio and the station or programs which students listen to must be approved by the Transportation Supervisor.

- 7. Students shall remain seated while the school bus is in motion and keep all parts of their bodies inside the bus. Students shall keep main bus aisle clear at all times.
- 8. Students shall not throw items inside of the bus or out of bus windows or doors and should not hold anything so that it extends out of the bus window.
- 9. Students must not tamper with or open a school bus emergency door unless directed to do so by the driver.
- 10. Selling or trading items on school buses is prohibited.
- 11. Eating, drinking or littering is not permitted on a school bus.
- 12. Possessing, using or selling tobacco is strictly prohibited on a school bus.
- 13. Abusive, profane or inappropriate language is not permitted.
- 14. Blankets of any shape and/or size are forbidden on school buses. Therefore, please dress appropriate for the weather.
- 15. No property of a student should be left on the school bus. If anything is accidently left it will be removed by the driver on a daily basis.
- 16. The following cargo is forbidden on school buses: pets, alcoholic beverages, illegal drugs, look-alike drugs, ammunition, explosives, firecrackers, firearms, knives, look-alike weapons, water dispensers, electronic games, pagers, glass containers, laser pointers, or any other dangerous materials or objects. If there is a question on the transportation of a particular item, the Transportation Supervisor should be consulted.
- 17. Materials that could be dangerous that are used for student projects or physical education classes should be transported by parents to and from school: e.g., live creatures, arrows, or any other forbidden school bus cargo.
- 18. Students will remain on their original bus if it is a shuttle bus going to his or her school of attendance.
- 19. Students waiting for shuttle buses must wait in areas assigned by the principal.
- 20. Students will not leave school grounds between bus transfers.
- 21. Bullying in any form (verbal or physical) will not be tolerated. Strict disciplinary action will be administered by the Building Administrator.

Student Conduct Code For Transportation Grades PK - 12

Discipline Control Program

(The building principal may bypass any of these steps if warranted.)

All situations cannot be covered in this manual.

All subsequent violations not listed may result in suspension from bus privileges.

Elementary Levels

- 1. Inappropriate Language spoken, written, or gesture
- 2. **Property** Defacing or destruction of property of others and/or school property, i.e., school buses
- 3. **Disrespect** to student, driver, or school personnel, refusal to obey reasonable request
- 4. Safety Violations
 - A. Throwing objects
 - B. Fighting
 - C. Having arms, hands, head, feet, or objects out of bus windows
 - D. Horseplay (distracting driver)
 - E. Eating or drinking
 - F. Not sitting in assigned seat
 - G. Excessive noise (disruptive)
 - H. Standing or moving while bus is in motion
 - I. Not following driver's signal to cross a road or not cross a road
 - J. Bullying
- 5. **Possession or use of tobacco products**: snuff, cigarettes, chewing tobacco, pipes, matches, lighters, vapor pens, etc.
- 6. Possession or use of illegal drugs, drug paraphernalia, or alcohol (alcohol may be determined by odor)
- 7. Possession of Dangerous Objects and Weapons

The following is a list of POSSIBLE CONSEQUENCES for the above actions:

- A. Warning
- B. Saturday School
- C. In-school suspension
- D. Removal from bus
- E. Loss of bus privileges for 1 to 80 days
- F. Written warning

Junior High/Secondary Level

(The building principal may bypass any of these if warranted)

1. Student Behavior

- A. Eating or drinking
- B. Not sitting in assigned seat
- C. Excessive noise (disruptive)
- D. Not following driver's signal to cross a road or not cross a road
- E. Standing or moving while bus is in motion
- F. Fighting
- G. Throwing objects
- H. Having hands, arms, head, feet, legs, or any objects protruding from bus, windows
- I. Displaying or using disrespectful behavior or language with others, either inside or outside bus. Language is defined as spoken, written, or gesture.
- J. Horseplay, such as distracting driver, bothering others by hitting, taking personal belongings, teasing others, etc.
- K. Intimidation, harassing, sexual harassment, bullying or being rude to others

2. Tobacco

- A. Possession of tobacco products: snuff, cigarettes, chewing tobacco, pipes, matches, lighters, vapor pens, etc.
- B. Using, selling, or distributing tobacco products: snuff, cigarettes, chewing tobacco, pipes, matches, lighters, etc.

3. Drugs and Alcohol

- A. Possession of illegal drugs, drug paraphernalia, or alcohol (alcohol may be determined by odor)
- B. Using, selling, or distributing illegal drugs or alcohol (alcohol may be determined by odor)

4. Destruction or Defacing of School Property or the Personal Property of Others

5. Possession of Dangerous Objects and Weapons

NOTICE

UNLESS OTHERWISE AUTHORIZED BY LAW, PURSUANT TO OHIO REVISED CODE SECTION 2923.122, NO PERSON SHALLKNOWINGLY POSSESS, HAVE UNDERTHE PERSON'S CONTROL, CONVEY OR ATTEMPT TO CONVEY A DEADLY WEAPON OR DANGEROUS ORDNANCE ONTO A SCHOOL BUS (SCHOOL SAFETY ZONE).

Extra Curricular Trips

- 1. Driver, coach, teacher, and/or chaperone must enforce this document.
- 2. Violations must be submitted to driver.
- 3. Bus Code of Conduct applies on all extra curricular trips.

Section 6

Procedures

- 1. Principals can request a bus driver to appear for a conference.
- 2. Vocational school student information regarding any offense will be forwarded to the building of attendance principal.
- 3. Parochial school student information regarding any offense will be forwarded to the building of attendance principal.
- 4. Suspension of special needs pupils shall be in accordance with the law.
- 5. A suspension from bus riding privileges means all buses, but does not include suspension from school; this means that attendance at school is still mandatory.
- 6. Surveillance with videotaping equipment may be conducted on school buses.
- * In all cases (PK-12) listed above, when circumstances warrant, the principal has the option to select another level of punishment subject to review by the Franklin Local Administrative Team.
- * Expulsion is the removal of a student for a period of up to eighty (80) school days or the number of school days remaining in the semester or term in which the incident that gave rise to the expulsion takes place, whichever is greater. If at the time of the expulsion, there are fewer school days than the number of days of expulsion, the Superintendent has the option to: apply the remaining period of expulsion to the following semester or school year, or impose a community service requirement beyond the end of the school year in lieu of applying the suspension or expulsion into the next school year. However, community service as an alternative to expulsion cannot be used when a firearm is involved.


